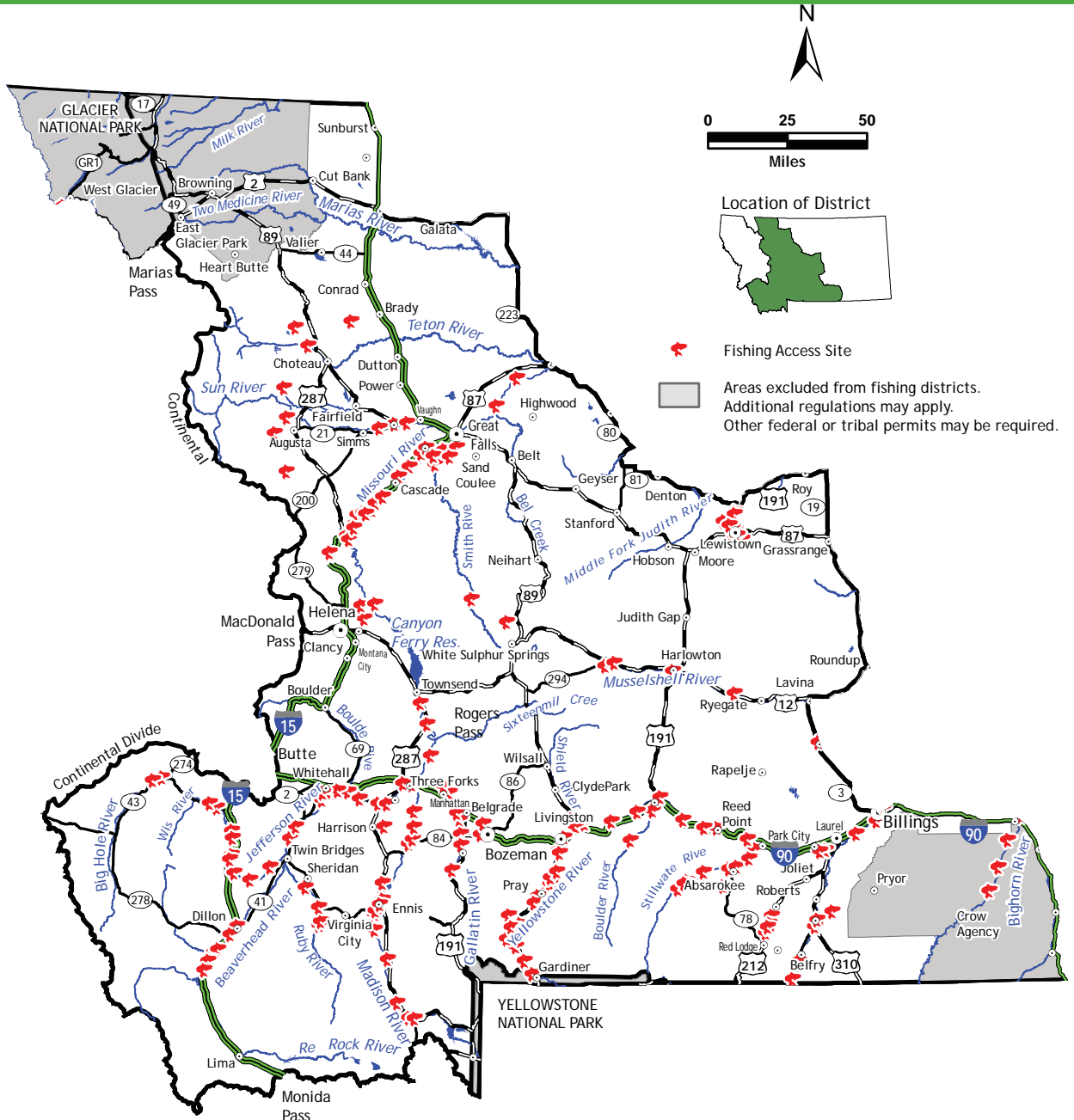

# Central Fishing District

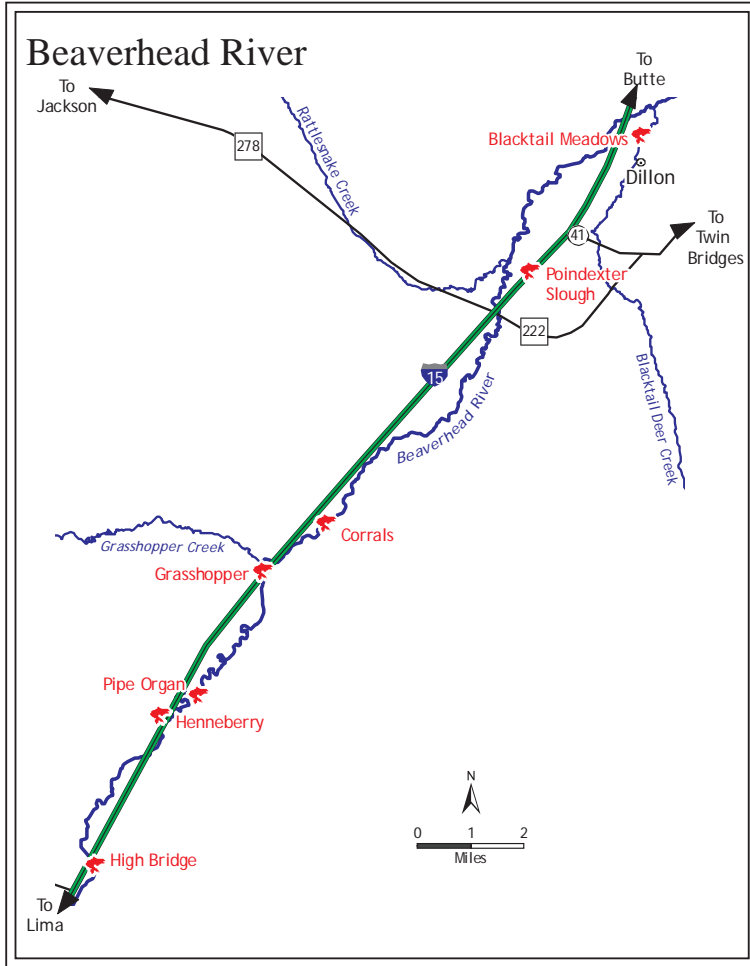
**The Central Fishing District includes all waters in Montana east of the Continental Divide, (including the Belly and St. Mary's River drainages) and west of the following described boundary:** Interstate 15 from the Montana-Canada border south to its junction with Hwy 2 at Shelby, then east on Hwy 2 to Chester, then south on Hwy 223 to State Hwy 80 at Fort Benton, then southeasterly along State Hwy 80 to its junction with State Hwy 81, then easterly on State Hwy 81 to its junction with U.S. Hwy 191, then northeasterly along U.S. Hwy 191 to its junction with State Hwy 19, then south on State Hwy 19 to its junction with U.S. Hwy 87 at Grassrange, then south on U.S. Hwy 87 to its junction with U.S. Hwy 12 at Roundup, then west on U.S. Hwy 12 to its junction with State Hwy 3 at Lavina, then south on State Hwy 3 to its junction with Interstate 90 at Billings, then easterly and southerly on Interstate 90 to the first crossing of the Little Bighorn River, then southerly along the west bank of the Little Bighorn River to the Montana-Wyoming border.

**Note:** Roadways that are used as boundaries between the Central and Eastern Fishing Districts are interpreted to be in the Central Fishing District.

# Beaverhead River



## Beaverhead River (Brown Trout, Mountain Whitefish, Rainbow Trout)

- See the Fishing Regulations for special rules applicable to the Beaverhead and Bighole Rivers.

### High Bridge - River Right, Mile 73

Day use only; year round; no boat ramp. Hunting and/or discharge of weapons prohibited.

**Directions:** 14 miles south of Dillon on I-15, to recreation road exit, then 4 miles south under I-15 bridge. (R3)

### Henneberry - River Right, Mile 70

Day use only; year round; gravel/river bottom boat ramp; access for trailers (max trailer length 20 ft); vault latrine; day use only on east side of river; camping allowed on west side of river; additional walk-in parking approximately 1 mile upstream.

**Directions:** 14 miles south of Dillon on I-15, to recreation road exit, then 2 miles south at I-15 underpass. (R3)

### Pipe Organ - River Right, Mile 68

Day use only; year round; concrete boat ramp; access for trailers (max trailer length 20 ft); vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** 14 miles south of Dillon on I-15 to Dalys exit, then 1.5 miles to site just over bridge. (R3)

### Grasshopper - River Left, Mile 63

Day use only; year round; concrete boat ramp. Hunting and/or discharge of weapons prohibited.

**Directions:** About 11 miles south of Dillon on I-15, Grasshopper Exit. Follow boat ramp signs to site. (R3)

### Corrals - River Left, Mile 61

Day use only; no boat ramp. Hunting weapons restricted - rifles prohibited.

**Directions:** 9 miles south of Dillon on recreational Frontage Road. (R3)

### Poindexter Slough - River Right, Mile 53

Day use only; no boat ramp; access for trailers (max trailer length 20 ft); vault latrine; walk-in area, two parking areas, no boat access. Hunting weapons restricted - rifles prohibited.

**Directions:** 3 miles south of Dillon on Montana 41. (R3)

### Blacktail Deer Creek (Brown Trout)

#### Blacktail Meadows (see Beaverhead River map) - River Left, Mile 1

Day use only; no boat ramp; vault latrine; in Dillon City limits. Kids fishing only (14 and younger). Hunting and/or discharge of weapons prohibited.

**Directions:** From Dillon proceed to I-15 interchange on north end of town. Turn on Swenson Way. (R3)

### Big Hole River (Arctic Grayling, Brook Trout, Brown Trout, Burbot, Mountain Whitefish, Rainbow Trout)

- See the Fishing Regulations for special rules applicable to the Beaverhead and Bighole Rivers.

#### Fishtrap Creek - River Left, Mile 81

20 campsites - fee charged for camping; year round; concrete boat ramp; access for trailers (max trailer length 28 ft); vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** 23 miles northeast of Wisdom on Hwy 43. (R3)

#### Sportsman's Park - River Left, Mile 78

Day use only; no boat ramp; vault latrine; managed by Anaconda Sportsmen's Club on Big Hole River.

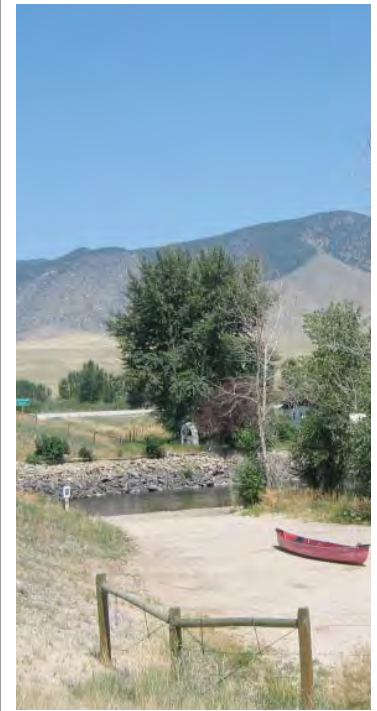
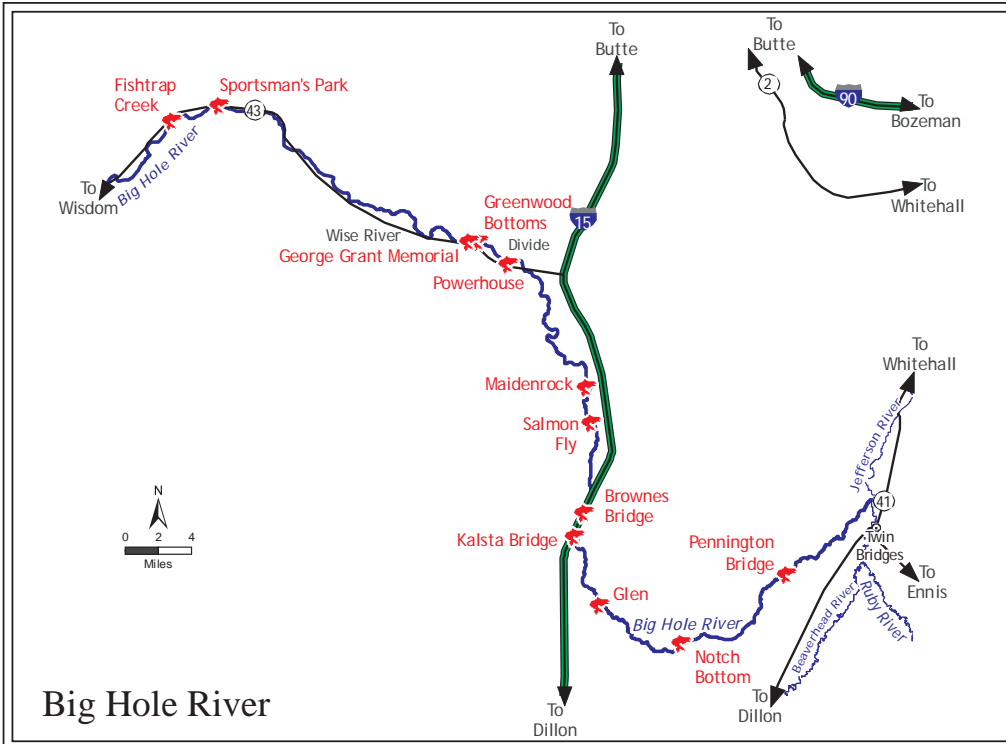
**Directions:** Hwy 43 about 14 miles west of Wise River, 3 miles past Hwy 274. (R3)

#### George Grant Memorial - River Right, Mile 57

Day use only; year round; concrete boat ramp; access for trailers (max trailer length 20 ft); vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** 7 miles west of Divide on State Hwy 43. (R3)

# Big Hole River

## Greenwood Bottoms

- River Right, Mile 57

Day use only; no boat ramp; access to river is difficult, access road dangerous. Open during established hunting seasons with no weapons restrictions.

**Directions:** 1.5 miles east of Dewey on State Hwy 43. (R3)

## Powerhouse

- River Left, Mile 54

Day use only; primitive boat ramp; vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** 2.5 miles west of Divide on State Hwy 43 to river bridge. Site lies on northeast corner. (R3)

## Maidenrock

- River Right, Mile 42

10 campsites - fee charged for camping; gravel/river bottom boat ramp; vault latrine; steep access road. Hunting weapons restricted - rifles prohibited.

**Directions:** I-15 at Melrose, milepost 93, then 6 miles northwest on County Road. (R3)

## Salmon Fly

- River Right, Mile 38

6 campsites - fee charged for camping; concrete boat ramp; access for trailers; vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** Hwy 15 to Melrose exit, then 0.25 mile on right. (R3)

## Brownes Bridge

- River Left, Mile 32

5 campsites; gravel/river bottom boat ramp; access for trailers (max trailer length 20 ft); vault latrine; historic interpretation of bridge on-site. Hunting and/or discharge of weapons prohibited.

**Directions:** 6 miles south of Melrose on the Frontage Road at Brownses Bridge. (R3)

## Kalsta Bridge

- River Right, Mile 30

Day use only; year round; no boat ramp. Hunting and/or discharge of weapons prohibited.

**Directions:** I-15 south to the Glen exit. Then 0.25 mile north on Frontage Road. Site lies southwest of river bridge. (R3)

## Glen

- River Right, Mile 25

7 campsites; year round; concrete boat ramp; access for trailers (max trailer length 30 ft); vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** 19 miles north of Dillon on I-15 to milepost 85, Glen Exit, then 6 miles south on Frontage Road. (R3)

## Notch Bottom

- River Left, Mile 18

3 campsites; gravel/river bottom boat ramp; access for trailers (max trailer length 20 ft); vault latrine; not on an all weather road. Hunting and/or discharge of weapons prohibited.

**Directions:** 4 miles south of Twin Bridges on State Hwy 41, then west on County Road for 10 miles. (R3)

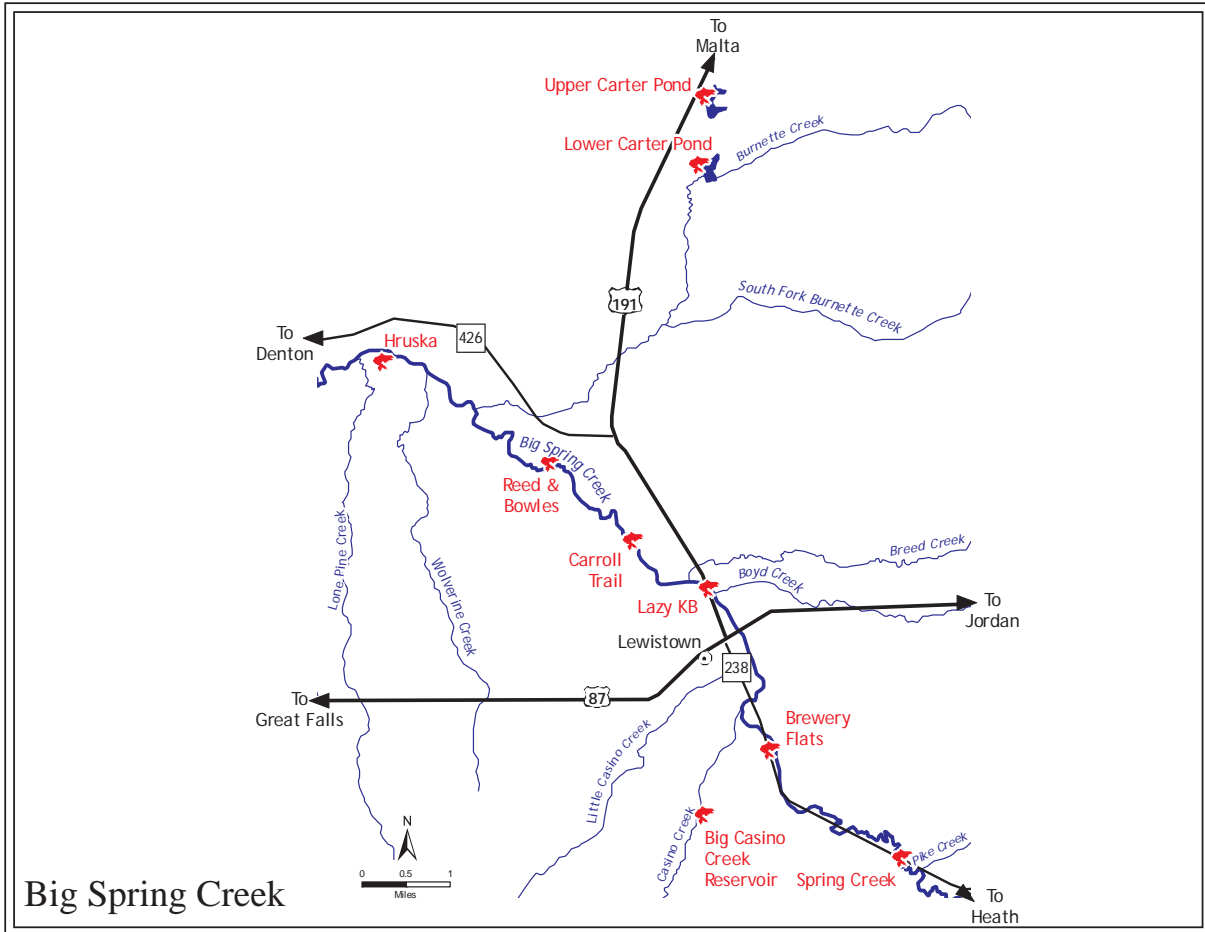
## Pennington Bridge

- River Left, Mile 9

Day use only; no boat ramp; vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** 4 miles south of Twin Bridges on State Hwy 41, then west on County Road for 3 miles. (R3)

# Big Spring Creek and Adjacent Areas



## Big Casino Creek Reservoir (Rainbow Trout, Walleye)

### Big Casino Creek Reservoir (see Big Spring Creek map)

Day use only; concrete boat ramp; vault latrine; ADA accessible fishing platform. Hunting and/or discharge of weapons prohibited.

**Directions:** 1.5 miles south of Lewistown off Castle Butte Rd. ADDRESS: 662 Reservoir Dr., Lewistown, MT (R4)

## Big Spring Creek (Brown Trout, Mountain Whitefish, Rainbow Trout)

### Spring Creek

- River Right, Mile 27

Day use only; no boat ramp; two sites approximately one mile apart. Hunting weapons restricted - rifles prohibited.

**Directions:** 3 miles south of Lewistown on Upper Spring Creek Rd (MT Hwy 238). ADDRESS: 3168 Upper Spring Creek Rd., Lewistown, MT (R4)

### Brewery Flats

- River Left, Mile 24

Day use only; no boat ramp; vault latrine; hiking trail. Hunting and/or discharge of weapons prohibited.

**Directions:** 1 mile south of Lewistown on Upper Spring Creek Rd (MT Hwy 238). ADDRESS: 11266 Upper Spring Creek Rd., Lewistown, MT (R4)

### Lazy KB

- River Left, Mile 21

Day use only; no boat ramp; vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** On edge of Lewistown city limits on US Hwy 191. ADDRESS: 256 US Hwy 191, Lewistown, MT (R4)

### Carroll Trail

- River Left, Mile 20

Day use only; no boat ramp.

**Directions:** 1 mile north of Lewistown on Joyland Road. ADDRESS: 116 Tresch Ln., Lewistown, MT (R4)

### Reed & Bowles

- River Right, Mile 18

Day use only; no boat ramp.

**Directions:** 2 miles North of Lewistown on Joyland Road. ADDRESS: 1977 Joyland Rd., Lewistown, MT (R4)

### Hruska

- River Left, Mile 15

Day use only; no boat ramp; vault latrine.

**Directions:** 6 miles northwest of Lewistown off Hanover Rd (MT Hwy 426), on Scott Crossing Rd. ADDRESS: 644 Scott Crossing N., Lewistown, MT (R4)

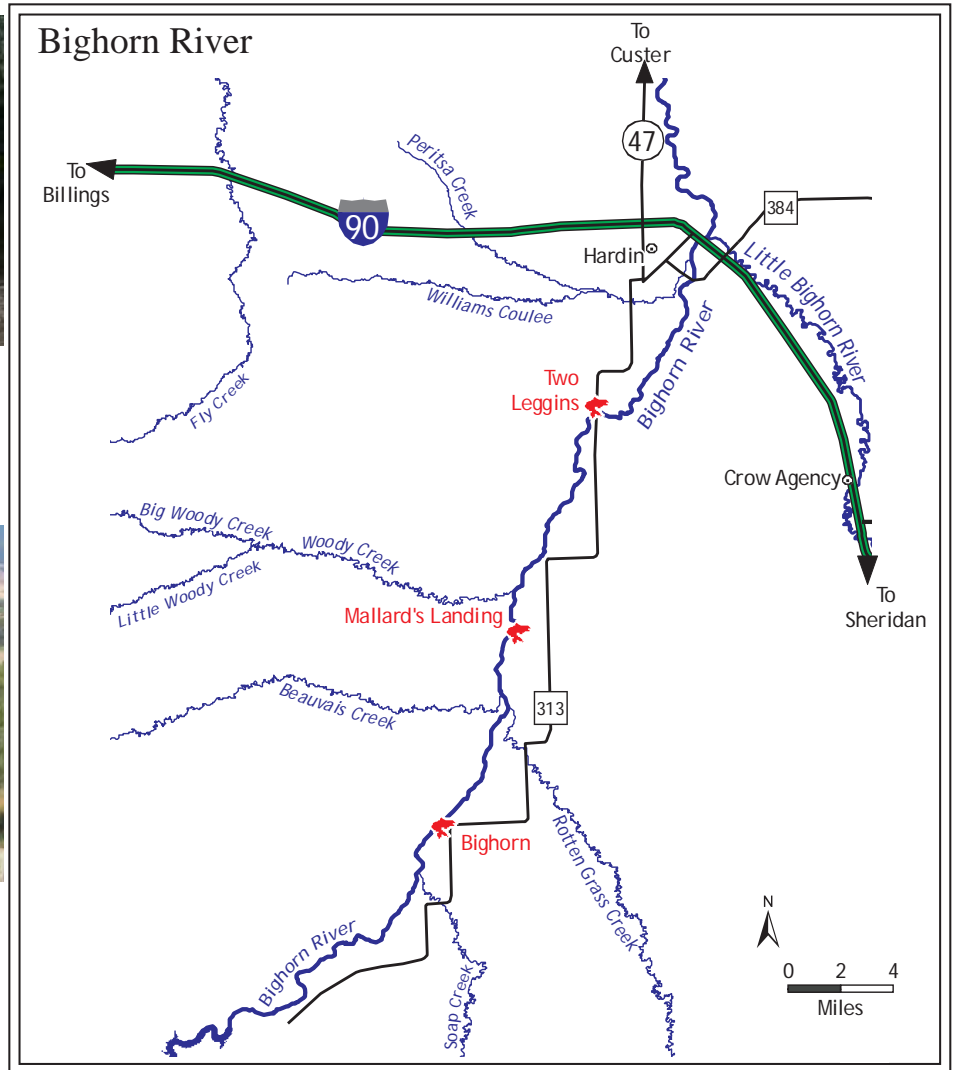

## Lower Carter Pond (Rainbow Trout)

### Lower Carter Pond (see Big Spring Creek map)

Day use only; hand launch only. Open during established hunting seasons with archery equipment only.

**Directions:** 9 miles northeast of Lewistown on US Hwy 191. ADDRESS: 6114 US Hwy 191, Lewistown, MT (R4)

## Upper Carter Pond (Rainbow Trout)

### Upper Carter Pond (see Big Spring Creek map)

Day use only; no boat ramp; vault latrine. Open during established hunting seasons with archery equipment only.

**Directions:** 11 miles northeast of Lewistown on US Hwy 191. ADDRESS: 6906 US Hwy 191, Lewistown, MT (R4)

## Bighorn River (Brown Trout, Burbot, Channel Catfish, Mountain Whitefish, Rainbow Trout, Sauger, Smallmouth Bass, Walleye)

### Bighorn

- River Right, Mile 72

5 campsites - fee charged for camping; concrete boat ramp (two ramps available); access for trailers; 2 vault latrines; heavily used by outfitters. Termination point for upper river floaters. Shotgun only during established waterfowl and upland game bird seasons.

**Directions:** 5.7 miles south of St. Xavier (no services) on Hwy 313. (R5)

### Mallard's Landing

- River Right, Mile 63

1 campsite; concrete boat ramp; access for trailers; vault latrine; Upper Bighorn River access. Good fishing & floating opportunities. Shotgun only during established waterfowl and upland game bird seasons.

**Directions:** 5.5 miles north of St. Xavier (no services) on Hwy 313, then west 1.8 miles. (R5)

### Two Leggins

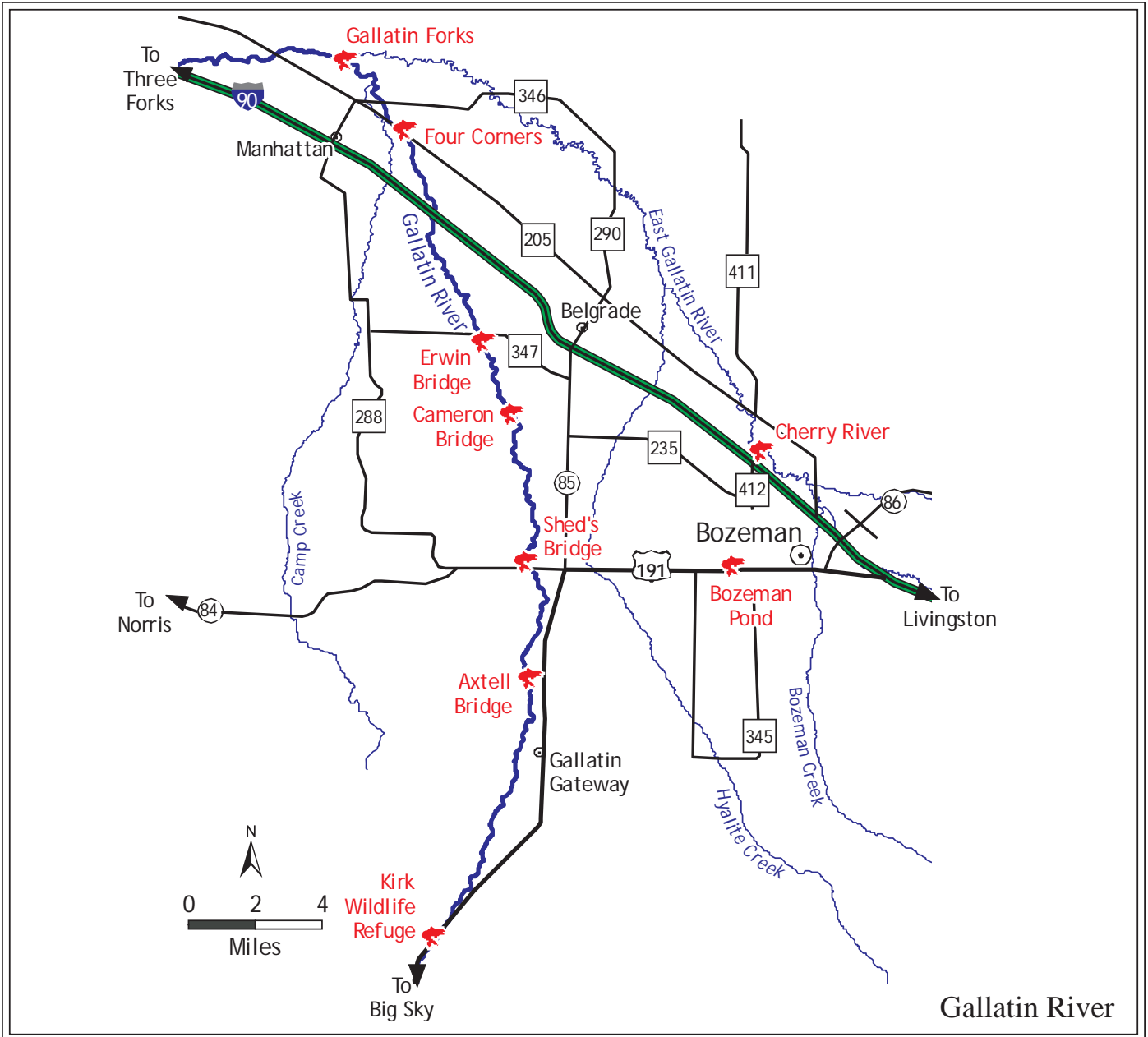
- River Left, Mile 52

1 campsite; concrete boat ramp; access for trailers; vault latrine; located on the Crow Indian Reservation. Good access to the Bighorn River. Shotgun only during established waterfowl and upland game bird seasons.

**Directions:** 6.5 miles south of Hardin on Hwy 313. (R5)

# Gallatin River and Adjacent Areas

## Bozeman Pond (Bluegill, Largemouth Bass, Rainbow Trout)

### Bozeman Pond (see Gallatin River map)

Day use only; open year round; no boat ramp; vault latrine; managed by the city of Bozeman. Hunting and/or discharge of weapons prohibited.

**Directions:** Hwy 191, west edge of Bozeman, milepost 87. Adjacent to Gallatin Valley Mall, west on Huffine, past mall, north on Fowler Lane. (R3)

## East Gallatin River (Brown Trout, Rainbow Trout)

### Cherry River (see Gallatin River map) - River Left, Mile 33

Day use only; no boat ramp; walk to river; hiking trails. ADA parking at City Water Treatment Plant. Hunting and/or discharge of weapons prohibited.

**Directions:** 1 mile north of Bozeman on Hwy 10. (R3)

## Gallatin River (Brown Trout, Mountain Whitefish, Rainbow Trout)

### Kirk Wildlife Refuge - River Left, Mile 46

Day use only; year round; no boat ramp; linear strip of west Gallatin River frontage. Hunting and/or discharge of weapons prohibited.

**Directions:** 5 miles south of Gallatin Gateway on Hwy 191, just north of Spanish Creek Road turn off. (R3)

### Axtell Bridge - River Right, Mile 37

Day use only; hand launch only; vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** 10 miles south of Belgrade on Hwy 191, milepost 77, then 1 mile west on Axtell Road. (R3)

### Shed's Bridge - River Left, Mile 33

Day use only; no boat ramp. Hunting and/or discharge of weapons prohibited.

**Directions:** 7 miles west of Bozeman on Montana 84. (R3)

### Cameron Bridge - River Right, Mile 27

Day use only; year round; no boat ramp; vault latrine. Hunting weapons restricted - rifles prohibited.

**Directions:** 2 miles south of Belgrade on Hwy 85, at milepost 5, then 2 miles west on West Cameron Bridge Road. (R3)

### Erwin Bridge - River Left, Mile 24

Day use only; year round; no boat ramp; vault latrine; walk in only. Hunting weapons restricted - rifles prohibited.

**Directions:** 4 miles west of Belgrade on Amsterdam Road (RT 347). (R3)

### Four Corners - River Right, Mile 16

Day use only; year round; no boat ramp; vault latrine; walk in only. Hunting and/or discharge of weapons prohibited.

**Directions:** I-90 at Manhattan, milepost 288, then 3 miles east on Secondary 346. (R3)

### Gallatin Forks - River Left, Mile 13

Day use only; year round; gravel/river bottom boat ramp (located at Nixon Bridge); there are two access points at this site. Access at Yadon Road is not recommended for trailers or RV's. Access at Nixon Bridge has a 10' limit for trailers. Hunting weapons restricted - rifles prohibited.

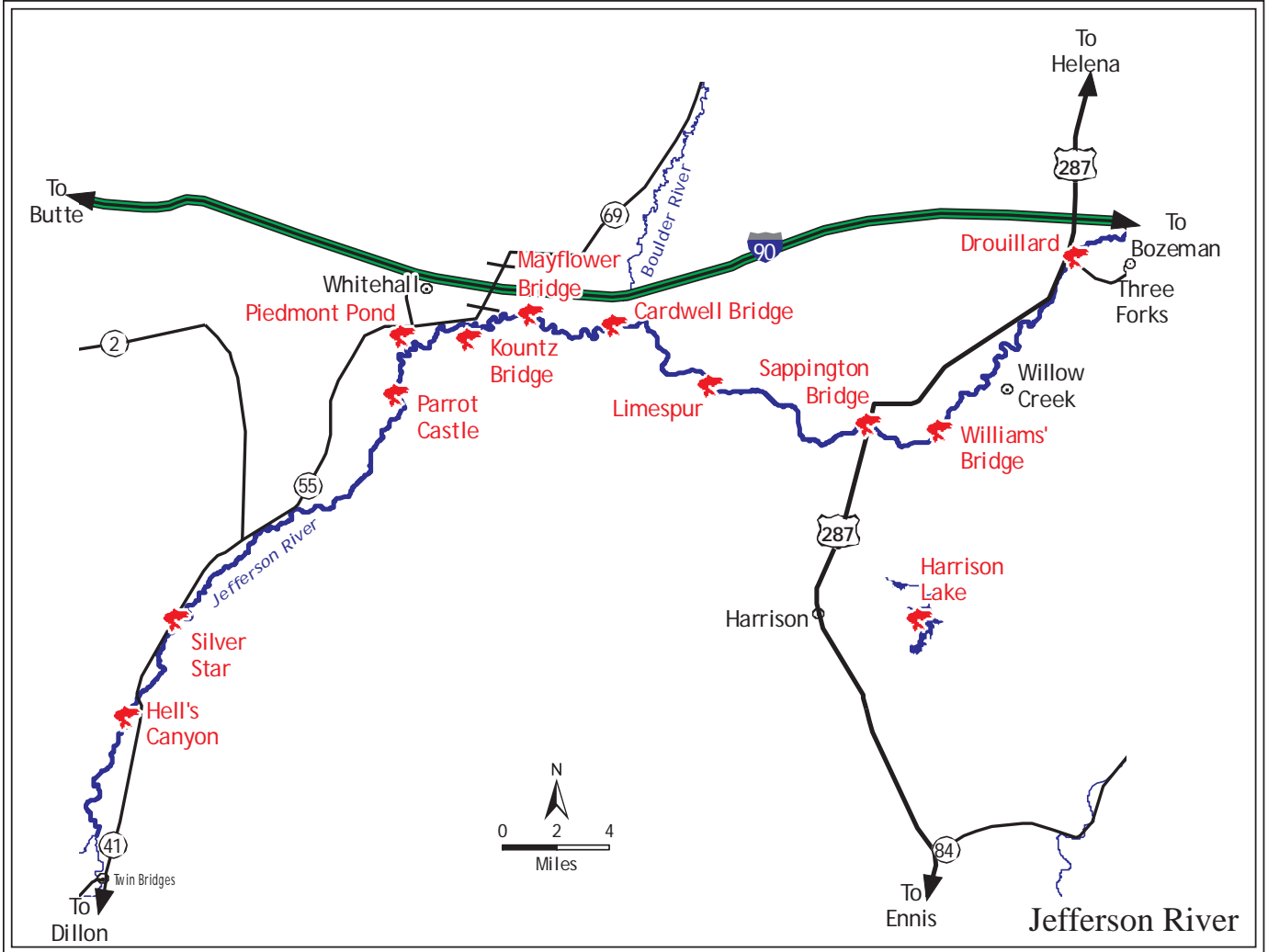
**Directions:** I-90 at Manhattan, milepost 288, then 2 miles north on Nixon Gulch Road; or, 1 mile on Dry Creek, then north on Yadon Road for 1.5 miles. (R3)

## Limespur

- River Left, Mile 29

Day use only; no boat ramp; access for trailers (max trailer length 20 ft). Hunting weapons restricted - rifles prohibited.

**Directions:** 17 miles west of Three Forks on State Hwy 2, across from Lewis & Clark Caverns State Park. (R3)

## Sappington Bridge

- River Left, Mile 22

Day use only; gravel/river bottom boat ramp. Hunting and/or discharge of weapons prohibited.

**Directions:** 11 miles west of Three Forks on Hwy 10, then 1 mile south on Hwy 287 to bridge. (R3)

## Williams' Bridge

- River Right, Mile 19

Day use only; gravel/river bottom boat ramp; access for trailers (max trailer length 20 ft); vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** I-90 west of Three Forks, exit 274, then 6 miles southwest on State Hwy 2, then 2 miles south on Williams' Bridge Road. (R3)

## Drouillard

- River Right, Mile 8

Day use only; year round; gravel/river bottom boat ramp; access for trailers (max trailer length 25 ft); vault latrine; the next take out point is 8 miles downstream at Headwaters State Park. Hunting weapons restricted - rifles prohibited.

**Directions:** 2 miles west of Three Forks on Route 2. (R3)

## Piedmont Pond (Westslope Cutthroat Trout)

### Piedmont Pond

Day use only; no boat ramp; vault latrine. Hunting weapons restricted - rifles prohibited.

**Directions:** From Whitehall take Kountz Bridge Road south for 2 miles. Turn on Piedmont Road, travel for 1 mile. (R3)

## Willow Creek Reservoir (Brown Trout, Rainbow Trout)

### Harrison Lake (see Jefferson River map)

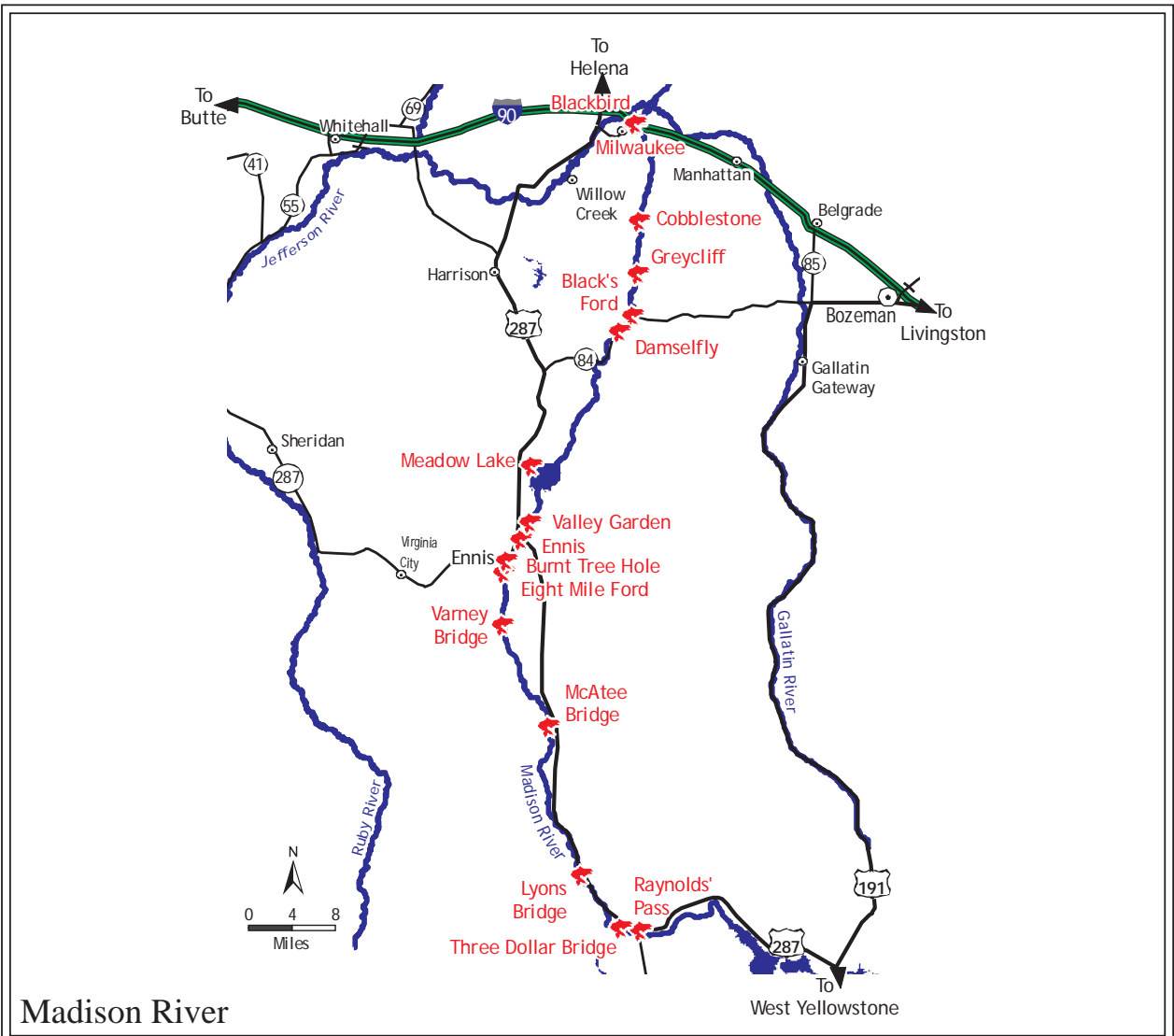
12 campsites - fee charged for camping; concrete boat ramp; access for trailers; vault latrine. Hunting weapons restricted - rifles prohibited.

**Directions:** 4 miles east of Harrison on County Road. (R3)

# Madison River



**Ennis Lake (Arctic Grayling, Brown Trout, Mountain Whitefish, Rainbow Trout)**

**Meadow Lake (see Madison River map)**

9 campsites; no boat ramp; access for trailers (max trailer length 25 ft); vault latrine; very shallow shoreline; boat ramp available at BLM site Kobayashi Beach. Hunting weapons restricted - rifles prohibited.

**Directions:** 6 miles north of Ennis on Hwy 287 to milepost 55, then 2 miles east on County Road. (R3)

**Madison River (Brown Trout, Mountain Whitefish)**

**Raynolds' Pass**

- River Right, Mile 98

6 campsites; closed in winter due to snow; gravel boat ramp (closed to fishing from boats); access for trailers (max trailer length 25 ft); vault latrine; trailers not recommended in walk-in parking area. Walk-in area located on east side of U.S. 87. Hunting weapons restricted - rifles prohibited.

**Directions:** 31 miles northwest of West Yellowstone on Hwy 287 to milepost 8, then 0.5 mile south to bridge. (R3)

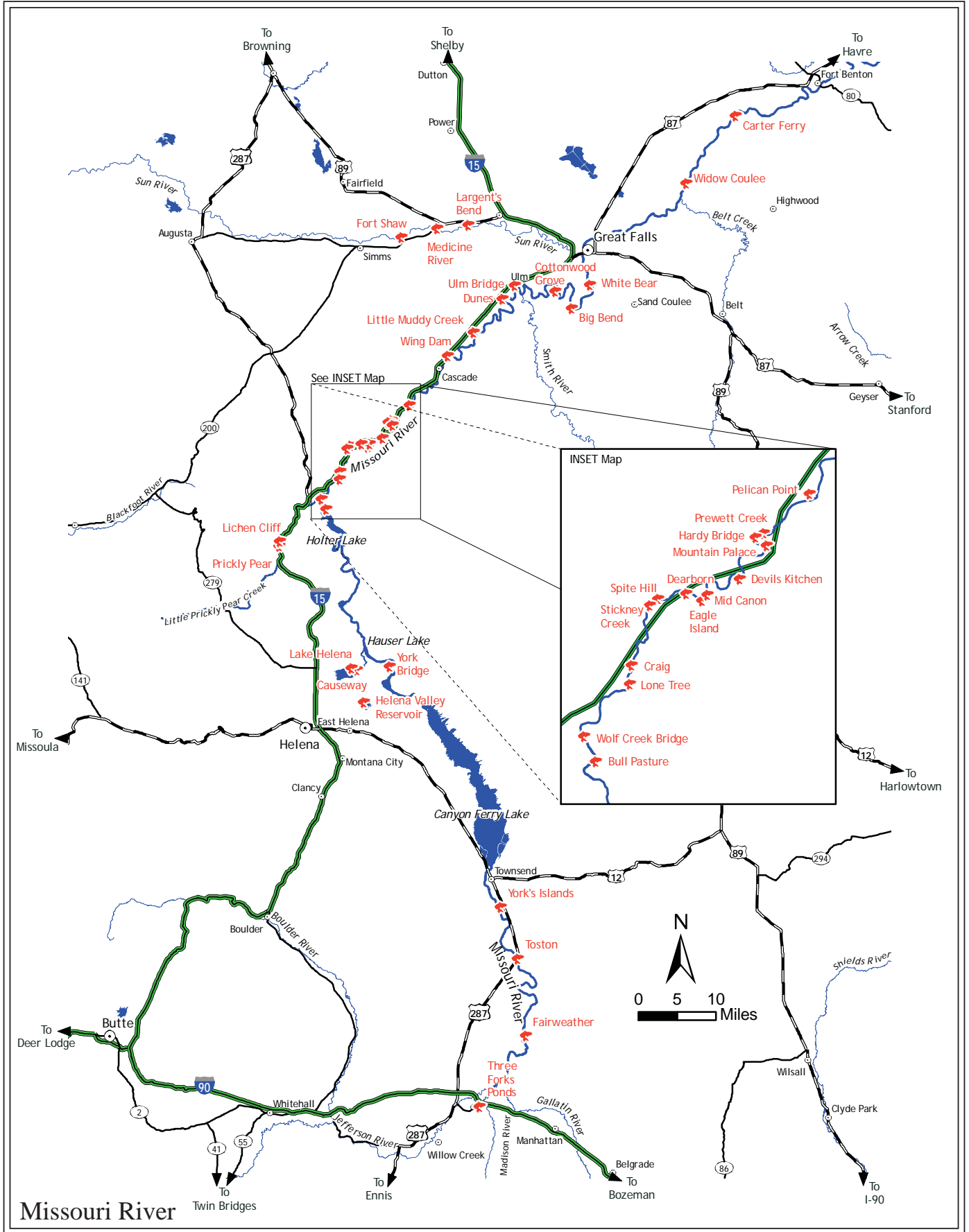

# Madison River

- Three Dollar Bridge** - River Right, Mile 95  
Day use only; no boat ramp (closed to fishing from boats); access for trailers (max trailer length 25 ft); vault latrine; walk in from US 287 in winter (0.5 mile). Hunting weapons restricted - rifles prohibited.  
**Directions:** 39 miles south of Ennis or 32 miles northwest of West Yellowstone on US 287. One mile downstream from Reynolds Pass Bridge. (R3)
- Lyons Bridge** - River Left, Mile 88  
Day use only; concrete boat ramp (boat fishing open downstream to Ennis); access for trailers; vault latrine; Forest Service site managed by Montana Fish, Wildlife & Parks. Hunting and/or discharge of weapons prohibited.  
**Directions:** 31 miles south of Ennis on Hwy 287. (R3)
- McAtee Bridge** - River Left, Mile 71  
Day use only; gravel/river bottom boat ramp; access for trailers; vault latrine. Hunting weapons restricted - rifles prohibited.  
**Directions:** 30 miles south of Ennis on Hwy 287, then 1 mile west to river on gravel road. (R3)
- Varney Bridge** - River Right, Mile 60  
8 campsites - fee charged for camping; concrete boat ramp; access for trailers (max trailer length 20 ft); vault latrine. Hunting weapons restricted - rifles prohibited.  
**Directions:** 1 mile west of Ennis on Hwy 287, then 10 miles south on County Road. (R3)
- Eight Mile Ford** - River Left, Mile 55  
Day use only; gravel/river bottom boat ramp; access for trailers (max trailer length 25 ft); vault latrine. Hunting and/or discharge of weapons prohibited.  
**Directions:** 1 mile west of Ennis on Hwy 287, then 4 miles south on County Road. (R3)
- Burnt Tree Hole** - River Left, Mile 53  
Day use only; concrete boat ramp; access for trailers (max trailer length 10 ft); vault latrine. Hunting and/or discharge of weapons prohibited.  
**Directions:** 1 mile west of Ennis on Hwy 287, then 2 miles south on County Road. (R3)
- Ennis** - River Right, Mile 51  
18 campsites - fee charged for camping; day use only from 12/01 to 04/01; gravel/river bottom boat ramp (closed to fishing from boats down river of Ennis Bridge); access for trailers (max trailer length 25 ft); vault latrine. Hunting weapons restricted - rifles prohibited.  
**Directions:** 0.5 mile southeast of Ennis on Hwy 287. (R3)
- Valley Garden** - River Right, Mile 49  
8 campsites - fee charged for camping; day use only from 12/01 to 04/01; gravel/river bottom boat ramp (closed to fishing from boats); access for trailers (max trailer length 25 ft); vault latrine. Hunting weapons restricted - rifles prohibited.  
**Directions:** Hwy 287, 0.25 mile south of Ennis to milepost 48, then 2 miles north on County Rd. (R3)
- Damselfly**  
Day use only; concrete boat launch; access for trailers (max trailer length 25 ft); vault latrine, gravel parking area. Hunting weapons restricted - rifles prohibited.  
**Directions:** Approximately 9 miles east of Norris on State Highway 84. (R3)
- Black's Ford** - River Right, Mile 24  
Day use only; concrete boat ramp; access for trailers; vault latrine; very busy site in the summer months. Black's Ford is a popular take-out spot for recreational floaters. Hunting and/or discharge of weapons prohibited.  
**Directions:** 23 miles west of Bozeman on Hwy 84. (R3)
- Greycliff** - River Right, Mile 20  
12 campsites - fee charged for camping; year round; gravel/river bottom boat ramp; access for trailers (max trailer length 25 ft); vault latrine; 8 additional campsites will be developed in 2013. Open during established hunting seasons with no weapons restrictions.  
**Directions:** 23 miles west of Bozeman on Hwy 84, then 6 miles north on Madison River Road. (R3)
- Cobblestone** - River Right, Mile 14  
Day use only; no boat ramp; access for trailers (max trailer length 25 ft); vault latrine; boats must be carried 300 ft to/from the river. During summer months, site closed by gate in the evening hours. Open during established hunting seasons with no weapons restrictions.  
**Directions:** 3 miles west of Logan on Frontage Road then 7 miles south on Madison River Road. (R3)

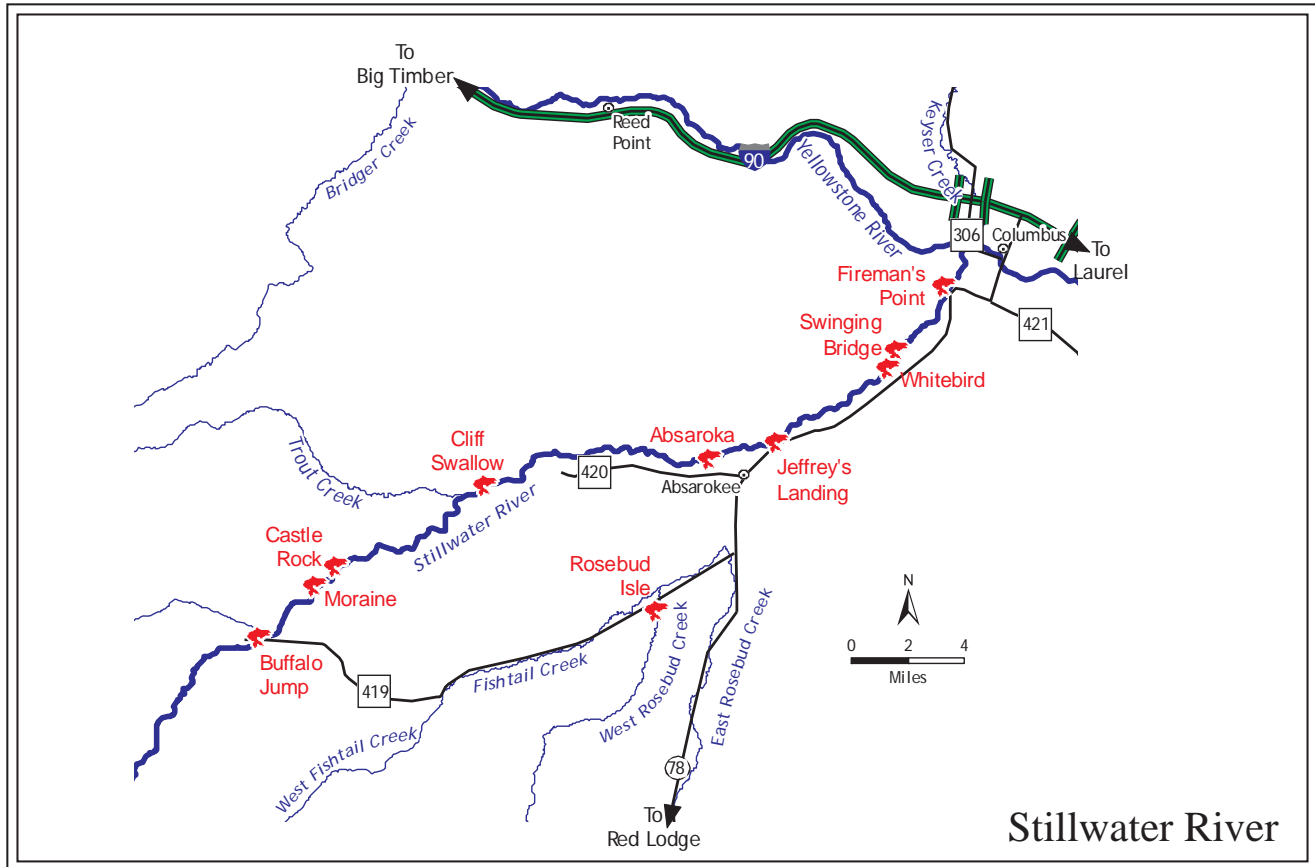

- Cliff Swallow** - River Right, Mile 23

8 campsites; hand launch only; access for trailers; vault latrine; disabled parking, fishing pier and sidewalk to toilet. Open with no restrictions during established hunting seasons except for safety zone closure in developed areas.  
**Directions:** 9 miles west of Absarokee on Hwy 420. (R5)

- Absaroka** - River Left, Mile 14

Day use only; hand launch only; access for trailers; vault latrine; small area, used for floater put in and take out. Two locations including small parking area 50 yard downstream of main site. Hunting and/or discharge of weapons prohibited.  
**Directions:** 1 mile west of Absarokee on Hwy 420, turn north onto Johnson Bridge 0.4 miles, then right on N. Stillwater Road after crossing the bridge. (R5)

- Jeffrey's Landing** - River Right, Mile 11

Day use only; concrete boat ramp; vault latrine. Hunting and/or discharge of weapons prohibited.  
**Directions:** 1.5 miles north of Absarokee on Hwy. 78 (R5)

- Whitebird** - River Right, Mile 6

10 campsites - fee charged for camping; gravel boat ramp; access for trailers; vault latrine; weapons closure in developed areas. Shotgun and archery only during established hunting seasons.  
**Directions:** 5.9 miles south of Columbus on Hwy 78. (R5)

- Swinging Bridge** - River Right, Mile 5

5 campsites; hand launch only; access for trailers; vault latrine. Hunting and/or discharge of weapons prohibited.  
**Directions:** 5.3 miles south of Columbus on Hwy 78. (R5)

- Fireman's Point** - River Left, Mile 2

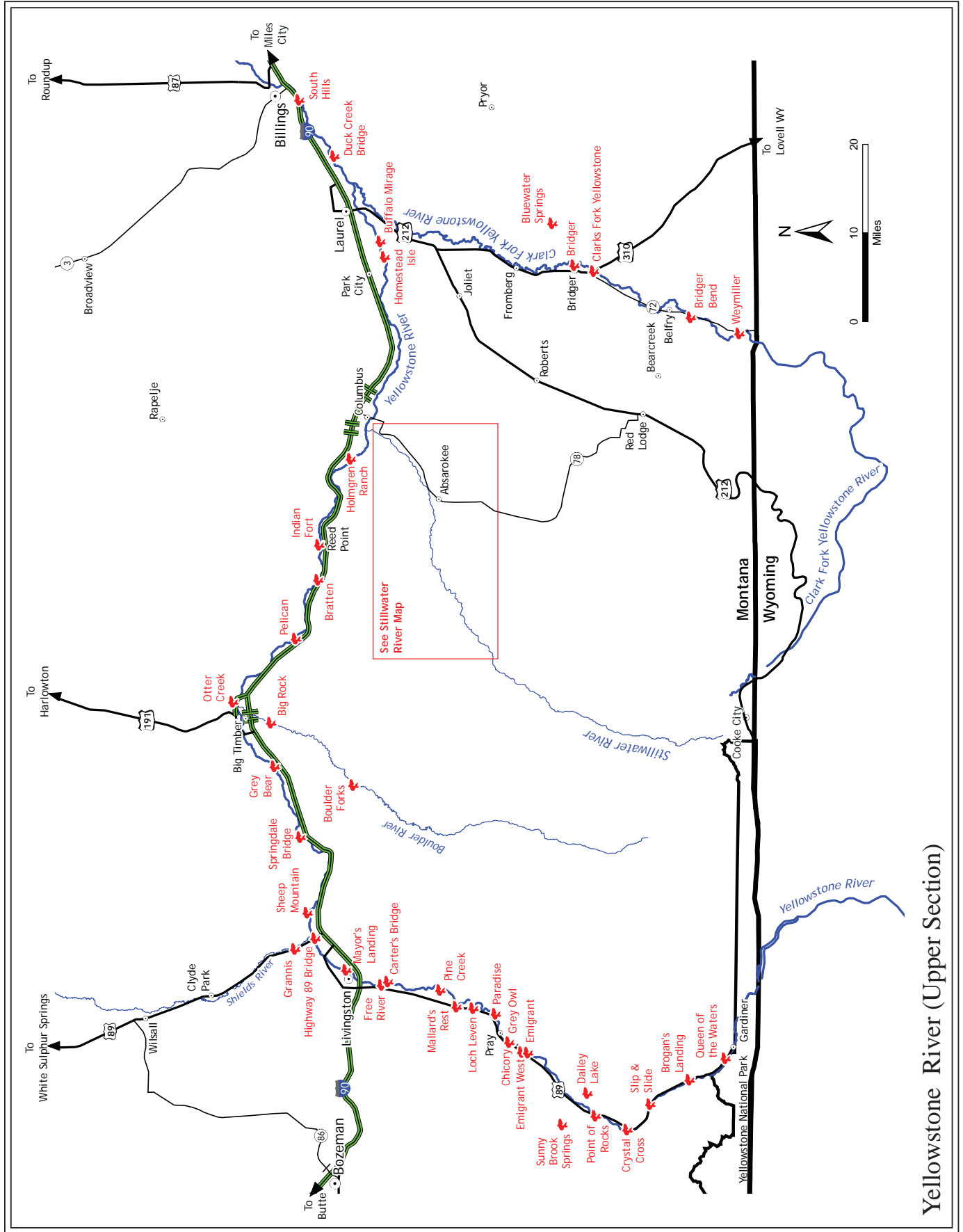
Day use only; Slide launch for rafts; access for trailers; vault latrine; no campfires. Shotgun and archery only during established hunting seasons.  
**Directions:** 1.9 miles south of Columbus on Hwy 78, then 0.5 mile west on Countryman Creek Road. (R5)

- West Rosebud Creek (Brook Trout, Brown Trout, Mountain Whitefish, Rainbow Trout, Yellowstone Cutthroat Trout)**
- Rosebud Isle (see Stillwater River map)** - River Right, Mile 4

8 campsites; hand launch only; access for trailers; vault latrine. Hunting and/or discharge of weapons prohibited.  
**Directions:** East off of Hwy 419 at Fishtail. Follow road past the post office and through a small group of private cabins. (R5)

## Big Creek (Brown Trout, Mountain Whitefish, Rainbow Trout, Yellowstone Cutthroat Trout X Rainbow)

### Sunny Brook Springs (see Yellowstone River (Upper) map) - River Right, Mile 4

1 campsite; year round; no boat ramp; one linear mile area along creek. Wade angling.

**Directions:** About 25 miles south of Livingston on US 89 to Big Creek Road then 3.5 miles west to Sunny Brook Springs. (R3)

## Bluewater Creek (Brown Trout, Rainbow Trout)

### Bluewater Springs (see Yellowstone River (Upper) map) - River Left, Mile 12

Day use only; no boat ramp; located adjacent to the Bluewater Fish Hatchery complex. No weapons restrictions. Hunters must register with hatchery personnel and be aware of safety zone around buildings/residences.

**Directions:** From Hwy 310 traveling through Bridger, turn east through town on E. Bradway Ave. and proceed 1.1 miles to E. Bridger Road. Turn left and travel 4.8 miles to Bluewater Road, then right 1.8 miles. (R5)

## Boulder River (Brook Trout, Brown Trout, Mountain Whitefish, Rainbow Trout, Yellowstone Cutthroat Trout)

### Boulder Forks (see Yellowstone River (Upper) map) - River Left, Mile 20

5 campsites; hand launch only; access for trailers; vault latrine; popular FAS on the Upper Boulder River. Shotgun and archery only during established hunting seasons.

**Directions:** From Hwy 191 in Big Timber, turn south on McLeod St./Hwy 298 and travel 16 miles. (R5)

### Big Rock (see Yellowstone River (Upper) map) - River Right, Mile 5

5 campsites; hand launch only; access for trailers; vault latrine; remote site. Open during established hunting seasons with archery equipment only.

**Directions:** I-90 exit 470 and drive into Big Timber 1.4 miles on Old Bridger Road. Turn south and continue 3.5 miles. (R5)

## Clarks Fork Yellowstone River (Brown Trout, Burbot, Mountain Whitefish, Rainbow Trout)

### Weymiller (see Yellowstone River (Upper) map) - River Left, Mile 68

Day use only; no boat ramp. Hunting and/or discharge of weapons prohibited.

**Directions:** 8.3 miles south of Belfry. Turn west on Chance Rd., cross the Yellowstone River. Continue 0.3 mile, entrance to the site is on the left. (R5)

### Bridger Bend (see Yellowstone River (Upper) map) - River Left, Mile 61

Day use only; no boat ramp; undeveloped site. No facilities. Shotgun and archery only during established hunting seasons.

**Directions:** 3 miles south of Belfry on Montana 72. (R5)

### Clarks Fork Yellowstone (see Yellowstone River (Upper) map) - River Left, Mile 45

Day use only; gravel boat ramp; vault latrine; parking for trailers; 150 yard firearms closure along northern boundary to Ridgeway Drive. Shotgun and archery only during established hunting seasons.

**Directions:** Approximately 2 miles south of Bridger, MT on State Highway 72. (R5)

### Bridger (see Yellowstone River (Upper) map) - River Left, Mile 42

Day use only; gravel/river bottom boat ramp. Hunting and/or discharge of weapons prohibited.

**Directions:** At Bridger, turn east on East Broadway, 0.5 mile. (R5)

## Dailey Lake (Rainbow Trout, Walleye, Yellow Perch)

### Dailey Lake (see Yellowstone River (Upper) map)

18 campsites - fee charged for camping; year round; 2 concrete boat ramps and docks; access for trailers; vault latrine. Open during established hunting seasons with no weapons restrictions.

**Directions:** 1 mile east of Emigrant, then 4 miles south on Secondary 240, then 6 miles southeast on County Road. (R3)

## Shields River (Brown Trout, Brook Trout, Cutthroat Trout, Mountain Whitefish, Rainbow Trout)

### Grannis (see Yellowstone River (Upper) map) - River Right, Mile 3

Day use only; no boat launch; walk-in access only. Hunting and/or discharge of weapons prohibited.

**Directions:** Northeast of Livingston on the Shields River, just east of Highway 89 and 4 miles North of Interstate 90. (R3)

## Yellowstone River (Upper) (Brown Trout, Burbot, Channel Catfish, Mountain Whitefish, Rainbow Trout, Sauger, Smallmouth Bass)

### Queen of the Waters - River Right, Mile 557

Day use only; no boat ramp. Hunting and/or discharge of weapons prohibited.

**Directions:** 55 miles south of Livingston on Hwy 89. (R3)

### Brogan's Landing - River Right, Mile 551

Day use only; gravel/river bottom boat ramp; steep access road to site. Hunting and/or discharge of weapons prohibited.

**Directions:** 48 miles south of Livingston on Hwy 89, milepost 7. (R3)

### Slip & Slide - River Right, Mile 546

Day use only; no boat ramp. Hunting and/or discharge of weapons prohibited.

**Directions:** 44 miles south of Livingston on Hwy 89. (R3)

<b>Crystal Cross</b>	- River Right, Mile 541
Day use only; year round; no boat ramp; parking limited. Hunting weapons restricted - rifles prohibited. <b>Directions:</b> About 33 miles south of Livingston on US 89 to the Tom Miner Road. Turn west 0.25 mile. Site on south side just before bridge. (R3)	
<b>Point of Rocks</b>	- River Left, Mile 537
Day use only; no boat ramp. Hunting weapons restricted - rifles prohibited. <b>Directions:</b> 30 miles south of Livingston on Hwy 89 at milepost 21. (R3)	
<b>Emigrant</b>	- River Right, Mile 525
Day use only; year round; gravel/river bottom boat ramp; access for trailers (max trailer length 20 ft); vault latrine. Hunting and/or discharge of weapons prohibited. <b>Directions:</b> 22 miles south of Livingston on Hwy 89 to milepost 31, then east across bridge. (R3)	
<b>Emigrant West</b>	- River Left, Mile 525
Day use only; year round; no boat ramp. Hunting weapons restricted - rifles prohibited. <b>Directions:</b> 21 miles south of Livingston on Hwy 89 to mile post 30 on east side of Hwy to river. The site is on the left side of the river as you float downstream. (R3)	
<b>Grey Owl</b>	- River Left, Mile 522
Day use only; year round; concrete boat ramp; access for trailers (max trailer length 20 ft); vault latrine. Hunting weapons restricted - rifles prohibited. <b>Directions:</b> 3 miles north of Emigrant on Hwy 89. (R3)	
<b>Chicory</b>	- River Right, Mile 522
Day use only; no boat ramp; access for trailers (max trailer length 20 ft). Hunting and/or discharge of weapons prohibited. <b>Directions:</b> 18 miles south of Livingston on Secondary 540, then 1 mile west on County Road. (R3)	
<b>Paradise</b>	- River Right, Mile 518
3 campsites; no boat ramp; access for trailers (max trailer length 20 ft); vault latrine. Hunting and/or discharge of weapons prohibited. <b>Directions:</b> 9 miles south of Livingston on Hwy 89 to milepost 44, then 2 miles east, then 4.5 miles south on Secondary 540. (R3)	
<b>Loch Leven</b>	- River Right, Mile 514
10 campsites - fee charged for camping; year round; concrete boat ramp; access for trailers; vault latrine. Hunting and/or discharge of weapons prohibited. <b>Directions:</b> 9 miles south of Livingston on Hwy 89 to milepost 44, then 2 miles east, then 4 miles south on Secondary 540. (R3)	
<b>Mallard's Rest</b>	- River Left, Mile 511
8 campsites - fee charged for camping; concrete boat ramp; access for trailers (max trailer length 30 ft); vault latrine; steep road into site. Hunting weapons restricted - rifles prohibited. <b>Directions:</b> 13 miles south of Livingston on Hwy 89 to milepost 42. (R3)	
<b>Pine Creek</b>	- River Left, Mile 508
Day use only; concrete boat ramp; access for trailers; vault latrine. Hunting and/or discharge of weapons prohibited. <b>Directions:</b> 3 miles south of Livingston on Hwy 89, then 7 miles south on Secondary 340 to Pine Creek, then 1 mile west on County Road. (R3)	
<b>Carter's Bridge</b>	- River Right, Mile 501
Day use only; year round; gravel/river bottom boat ramp; vault latrine; limited parking. Hunting and/or discharge of weapons prohibited. <b>Directions:</b> 3 miles south of Livingston on Hwy 89 then 0.25 mile east on Secondary 540 (East River Road). (R3)	
<b>Free River</b>	- River Left, Mile 500
Day use only; no boat ramp; walk in only. Hunting weapons restricted - rifles prohibited. <b>Directions:</b> 2.5 miles south of Livingston on Hwy 89. (R3)	
<b>Mayor's Landing</b>	- River Right, Mile 495
Day use only; concrete boat ramp; access for trailers (max trailer length 25 ft); vault latrine; managed by City of Livingston. Hunting and/or discharge of weapons prohibited. <b>Directions:</b> Southeast side of the city of Livingston on View Vista Drive, near fairgrounds. (R3)	
<b>Highway 89 Bridge</b>	- River Right, Mile 489
Day use only; year round; concrete boat ramp; vault latrine. Hunting and/or discharge of weapons prohibited. <b>Directions:</b> 5 miles east of Livingston on I-90, take Hwy 89 exit, 1 mile north on Hwy 89. (R3)	

# Yellowstone River (Upper Section) and Adjacent Areas

## Sheep Mountain

- River Left, Mile 486

Day use only; gravel/river bottom boat ramp; access for trailers (max trailer length 20 ft); vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** 4 miles east of Livingston on I-90 to milepost 340, then 2 miles north on Hwy 89, then 4 miles east on County Road. (R3)

## Springdale Bridge

- River Right, Mile 473

Day use only; gravel/river bottom boat ramp; access for trailers (max trailer length 25 ft); vault latrine. Hunting weapons restricted - rifles prohibited.

**Directions:** I-90 Springdale exit to town of Springdale, then 0.5 mile north. (R3)

## Grey Bear

- River Right, Mile 464

10 campsites - fee charged for camping; gravel boat ramp; access for trailers; vault latrine; large open area for camping and picnicking. Shotgun and archery only during established hunting seasons.

**Directions:** I-90 Exit 367, north to Frontage Road, then 5 miles west. Turn north on N. Yellowstone Tr. Road, then 0.5 mile. (R5)

## Otter Creek

- River Left, Mile 454

3 campsites; concrete boat ramp; access for trailers; vault latrine; Upper Yellowstone River access. Clark on the Yellowstone interpretive site. Shotgun and archery only during established hunting seasons.

**Directions:** 2 miles north of Big Timber on Hwy 191, then 1.5 miles east on Howie Road. (R5)

## Pelican

- River Right, Mile 442

3 campsites; concrete boat ramp; access for trailers; vault latrine; upper Yellowstone River access. Open during established hunting seasons with no weapons restrictions.

**Directions:** I-90 Exit 392 to North Frontage Road, west 12.2 miles, then north 0.3 miles on Lower Sweet Grass Road. (R5)

## Bratten

- River Left, Mile 434

5 campsites - fee charged for camping; gravel/river bottom boat ramp; access for trailers (max trailer length 25 ft); vault latrine; good access to the Yellowstone River for fishing/float. 'Clark on the Yellowstone' interpretive site. Open during established hunting seasons with no weapons restrictions.

**Directions:** I-90 Exit 392 to North Frontage Road, then west 4.5 miles. (R5)

## Indian Fort

- River Left, Mile 430

12 campsites - fee charged for camping; gravel/river bottom boat ramp; access for trailers; vault latrine. Hunting and/or discharge of weapons prohibited.

**Directions:** I-90 Exit 392, to North Frontage Road, then north 0.5 mile to first left after crossing the bridge. (R5)

## Holmgren Ranch

- River Left, Mile 417

Day use only; concrete boat ramp; access for trailers; vault latrine; parking for trailers. Open during established hunting seasons with no weapons restrictions.

**Directions:** Approximately 5 miles west of Columbus on Springtime Rd. Access currently limited to float in from the Yellowstone River (R5)

## Homestead Isle

- River Right, Mile 389

Day use only; no boat ramp; island site. River access only. Open during established hunting seasons with no weapons restrictions.

**Directions:** Yellowstone River site south of Park City (no vehicle access). (R5)

## Buffalo Mirage

- River Left, Mile 387

Day use only; gravel/river bottom boat ramp; access for trailers; vault latrine; site also known as Sportsman's Park. Good access to the Yellowstone River. Opens at 5:00am. Closed after 10:00 pm. Shotgun and archery only during established hunting seasons.

**Directions:** I-90 Exit 426, south through Park City on S. Clark 0.7 miles. Travel east on Cemetery Rd 3.2 miles, then south. (R5)

## Duck Creek Bridge

- River Right, Mile 375

Day use only; concrete boat ramp; access for trailers; vault latrine; access dependant on water level. Shotgun and archery only during established hunting seasons.

**Directions:** I-90 Exit 443, south to Frontage Road, 2 miles west to Duck Creek Road. South 1.3 miles, turn left and proceed 0.7 miles. (R5)

## South Hills

- River Right, Mile 366

Day use only; no boat ramp; no vehicle access to river. Hunting and/or discharge of weapons prohibited.

**Directions:** Blue Creek Road, turn left at Blue Basket, proceed 0.5 mile. (R5)
