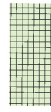


## EXPLANATION OF LEGEND ITEMS



**National Forest lands open to over-snow vehicles (snowmobiles only)** - Areas open to over-snow vehicles within the Gallatin National Forest are limited to snowmobiles. A snowmobile is defined as a motorized vehicle 50 inches or less in width, designed for use over snow, runs on a track and uses one or more skis for steering. All other over-snow vehicles are prohibited year-long.



**National Forest lands where over-snow vehicles (snowmobiles only) are seasonally restricted** - These areas are where snowmobiles are prohibited seasonally between October 15 and December 2 on the Gallatin National Forest. A snowmobile is defined as a motorized vehicle 50 inches or less in width, designed for use over snow, runs on a track and uses one or more skis for steering. All other over-snow vehicles are prohibited year-long.

**Hyalite Porcupine Buffalo Horn Wilderness Study Area** - Snowmobile and over snow vehicle use within the HPBH WSA is currently regulated by special order closure under 36 CFR 261.50 (a) and (b). **Groomed Snowmobile Trail** - Routes managed for snowmobiles, with occasional grooming. All wheeled motor vehicles are prohibited from traveling on groomed snowmobile trails from January 1 through April 15. These trails are marked with orange diamonds.



**Groomed Snowmobile Trail** - Routes managed for snowmobiles, with occasional grooming. All wheeled motor vehicles are prohibited from traveling on groomed snowmobile trails from December 2 through April 15. These trails are marked with orange diamonds.



**Marked Snowmobile Trail** - Marked routes managed for snowmobiles. Routes may be occasionally groomed for snow compaction only, not for user convenience. All wheeled motor vehicles are prohibited from traveling on marked snowmobile trails from December 2 through April 15. These trails are marked with orange diamonds.



**Groomed Cross Country Ski / Snowshoe Trail** - Groomed routes managed for cross country skiing and snowshoeing. Snowmobiles prohibited year long on these trails. All wheeled motor vehicles are prohibited from traveling on groomed ski/snowshoe trails from December 2 through April 15. These trails are marked with blue diamonds.



**Marked Cross Country Ski / Snowshoe Trail** - Marked routes managed for cross country skiing and snowshoeing. Routes may be occasionally groomed for snow compaction only, not for user convenience. All wheeled motor vehicles are prohibited from traveling on marked ski/snowshoe trails from December 2 through April 15. Marked ski trails that are located in areas where over-snow vehicles are prohibited are also closed to all over-snow vehicle use. Marked ski trails located in areas open to snowmobiles, unless otherwise noted, area also open for snowmobiling. Ski trails are marked with blue diamonds.



**Marked Cross Country Ski / Snowshoe Trail (Over-Snow Vehicles Prohibited)** - Marked routes managed for cross country skiing and snowshoeing. Routes may be occasionally groomed for snow compaction only, not for user convenience. All over-snow vehicles are prohibited yearlong on these trails. All wheeled motor vehicles are prohibited from traveling on marked ski/snowshoe trails from December 2 through April 15. These trails are marked with blue diamonds.



**Designated Motorized Route Through Closed Areas** - These are routes that are managed neither as ski nor snowmobile trails, but are open to wheeled motorized vehicles and snowmobiles (unless otherwise noted), through otherwise closed areas or private land. Motorized vehicles must stay on the designated route.



**Shared Use Trail** - These are routes that are managed both as marked ski trails and snowmobile access routes. Please use caution on these mixed use routes.
